Wear and Tear Items

Item Name	Item Comments
Engine Oil	The unit's engine oil appears dark, unit may need a service and standard inspection.
Left Track	The track has small cuts and gouges in it.
Coolant Cap	The coolant reservoir cap was missing at the time of inspection but has since been replaced.
Exhaust Heat Shielding	The exhaust heat shielding in the engine bay is dented and hood heat shielding appears ripped.
Bucket Lubricant Lid	The front lubricant bucket lid that has the cylinder on top of it is bent.
Engine Hood	The engine hood is damaged on the top left corner and may need repairs.
Rear access Door	The rear access door handle appears damaged and door has small dents in it.
Front Tilt Cylinder	The front tilt cylinder appears wet and may be leaking.
Floorboard	The floorboard cover/traction surface is worn and damaged.
Broken Button	The unit has a broken button to the right of the operator.
Operator Joy Sticks	The unit's joy sticks at the front of the unit appear worn and button caps are yellowed.
Drill Rods	The unit's drill rods are rusted as common with used drill rods, unit's rod reloader does operate.
Rod Carriage	The unit's rod carriage has rust damage and small dents in the side of the unit.
Work Lights	The unit has multiple non-operational work lights. The front work light does operate. The front work lights have internal LEDs that aren't lit, and the lights will need repairs.
Paint	The unit's paint is damaged all over the unit.
Rust	The unit has rust damage all over the unit.
Hydraulic Leak	During the operational video, before the unit was moved from its parking spot, there was a fresh puddle of hydraulic fluid. The unit will need diagnostics and repairs.
